Listening Devices and Motorcycles

Motorcyclists rely on their senses to operate safely. We know the importance of being able to hear oncoming traffic, horns, sirens, and other sounds that could indicate unsafe situations or a need to adjust our speed. Unlike those days in a patrol car, for those that had that privilege, we commonly were being paid to be inattentive to driving...simply because we had to be cognizant of so many other things.

As people age, it's common to experience hearing loss, as well as night vision. Hearing issues affect almost 27% of individuals over the age of 64. Although this number drops when considering all adults over 17, 13% of all adults have hearing issues.

Florida laws, subjective to the driver only, allow those of us who need hearing aids to wear these assistive devices while operating a motorcycle. However, these laws also prohibit drivers from wearing headphones or other listening devices that sit on or in their ears. Drivers are permitted to wear helmets with headsets as long as the headsets aren't touching their ears. Under certain conditions, drivers are also allowed to wear headsets that only transmit sound to one ear, and they may also use a headset that connects to their smartphone again only transmitting to one ear. What is the role of religion and spirituality in policing? By: Pastor Ed Kelley



Many officers take the stress they experience from their job back to their home lives, which can cause even more turmoil.

A typical table has four legs. We have all experienced a table that is out of balance, where one leg is "off", and the silly table unsteadily rocks back and forth. I like to think of life like the four legs of a table, each representing the four key areas of our existence: physical, emotional (social), mental and spiritual.

A table needs equal strength from all four legs in order to handle any significant weight placed upon it. If one leg is weak, the table can come crashing down. Life is the same way: The human life needs physical, emotional, mental and spiritual balance so when life's stresses land in our life—as they always do—we can handle it. Officers tend to hold their actions and behaviors to very high standards.

Stress can feel really heavy law enforcement, as a profession, is extremely stressful. Officers can experience stress from all sorts of sources: responding to calls for service; leadership within the department; society's expectations; spouses and family members; finances; or even from within, as officers tend to hold their actions and behaviors to very high standards. Officers often feel they are under constant stress, and this weight can accumulate over time. High levels of stress can also come from a single event, whether it's responding to a car accident or being involved in a use-of-force incident. Unfortunately, many officers take the stress they experience from their job back to their home lives, which can cause even more turmoil.

I have worked with law enforcement for 30 years. I have counseled officers whose out-of-balance work lives ended up crashing their personal worlds. Quite often, officers crash when their lives are out of balance over an extended period of time. Whether it's the emotional (social) or mental sides of life that are weak—or if they are ignoring the spiritual aspect—out-of-balance lives create risk. After all, a three-legged table is not very good at handling weight that is thrown on it.

As a Christian pastor, I help officers deal with the emotional and spiritual aspects of their lives. I have found that many officers ignore spirituality. That worries me because I know how valuable faith, be it Christian or otherwise, can be for helping the average person get through life's stresses, so it's even more important to officers who experience much greater levels of stress.

Part of the reason officers do not address the spiritual side of life can be attributed to their inconsistent and downright crazy work schedules. Many officers work night shifts, weekends, and are on call, so attending religious services or maintaining relationships at a house of worship can be difficult to manage.

Another reason officers often neglect the spiritual side of life is that they have seen so many bad things. Officers deal with the lowest of the low in society and they've also seen horrific things, from gruesome crimes to tragic accidents. This can harden a person's outlook towards people and life in general. However, this is even more of a reason why officers need to find some element of spirituality in their lives. Spirituality helps people gain perspective on their life's events and can help bring balance, perspective, and even gratitude for what they have. Finding spirituality also drives many people into a service task such as participating in missions and local charities to help them give back and contribute in a different, and often therapeutic, way.

Throughout my 35 years as a pastor, I have found that almost all the officers who share with me their frustrations, challenges and pain are able to find some sort of solace when they focus on their spiritual life.

Officers come to me with all different backgrounds and experiences in spirituality. Those who start with no spiritual foundation and spend some time investigating faith are usually drawn out of the malaise of their daily life. Officers who have a moderate understanding and practice of faith normally just need to be reminded of what is important in the grand scheme of life and are able to renew their focus on the spiritual leg of their table. For those who are strong in faith, reiterating together what is true in divinity usually helps strengthen their life's spiritual journey even further.

My message to every officer I work with, regardless of their faith, is that stress is a killer. It destroys lives and can cause incredible damage to a person's well-being. Officers need to find ways to cope with and address their stress, so it doesn't eat them from the inside out. My job is to help people think through what is right, and what is important in life, so that stress doesn't get a hold of one of their "legs." For me, as someone who has a Christian worldview, I believe that stress can be

lessened when one understands his or her purpose in life. When officers take the time to ensure that the legs of their own table are in balance, they are much better equipped to handle the weight of life.

Well, it's time to start getting in shape! I already wrote articles on stretching, endurance vs strength training and choosing the right diet that fits your needs.

Now we will start with an upper/lower split.

Training upper/lower splits means you are targeting each muscle group at least twice a week, and if you have time, even three times per week. Each workout could include 2-4 different exercises per muscle group on a given day. Which can lead to 4-12 different ex-

ercises per muscle group per program.

The first question people ask is how many exercises should I do? Well, that answer depends on you and what your goals are? To simplify things, let's start off with a routine of two exercises per body part.

(Note): YouTube is a great source for getting familiar with the exercise movements, form is very important and go with light weights to start.

(1) Warm-up: 10 Minutes of cardio, followed by good stretching!

Chest: Flat bench 3 sets at 10 reps

Incline bench 3 sets at 10 reps

Back: Wide grip pull downs; 3 sets at 10 reps

Close grips pull downs; 3 sets at 10 reps.

Shoulders: Seated shoulder press machine; 3 sets at 10 reps

Side lateral dumbbells; 3 sets at 10 reps

Legs: Leg Press machine; 3 sets at 10 reps

Leg Extension machine; 3 sets at 10 reps.

Let's wrap things up, don't forget to stretch, and do another 10 mins of cardio (your choice)! Also, drink plenty of water before, during and afterwards, hydration is very important part of the process.

A CAREER WITH NOAA

Since receiving the honor of joining the Blue Knights the question of what NOAA's Office of Law Enforcement (NOAA OLE) is all about has come up from time to time. No doubt it is not the usual law enforcement background. I thought I would take a moment to offer some information on NOAA (National Oceanic and Atmospheric Administration) and the two organizations with which I was privileged to be associated during my 33 year career with the federal government, the NOAA Corps and NOAA's Office of Law Enforcement.

NOAA is under the US Department of Commerce (a mystery to us all as to why) and is the umbrella agency for several organizations, the most well known being the Weather Service which is a huge component. The others are listed below.



NOAA Line Offices

NOAA Marine & Aviation Operations (OMAO)

NOAA Marine Fisheries Service (NMFS)

National Ocean Service (NOS)

Office of Oceanic and Atmospheric Research (OAR)

National Weather Service (NWS)

National Environmental Satellite, Data, and Information Service (NESDIS)

Another major responsibility of the Agency is to serve the public through management of the marine environment and its resources. That was the mission to which I devoted my career, first in the marine research side of the organization through the NOAA Corps under the Office of Marine & Aviation Operations, and then by joining NO-AA's law enforcement section in the Marine Fisheries Service.

I was unaware either of these agencies existed during my college days at Ball State University in Indiana. After all, Indiana was not known for its oceanic connections and history. In fact, my goals at the time were far from where I ultimately landed.

I originally wanted to join the Indiana State Police when I was of age, but as it turned out I did not meet the minimum height requirement in place at the time. Ultimately, I ended up in the sciences in college and later found employment as an environmental scientist for the State of Indiana and thought my career would be in the earth sciences. However, I made the decision to take a different route and applied for a commission in the NOAA Corps.

The NOAA Corps is a non-military, uniformed corps of commissioned officers, much like the Public Health Service except with science and engineering backgrounds. The mission of the NOAA Corps is to support NOAA by operating NOAA scientific platforms (ships and aircraft), managing research projects, conducting diving operations, and serving in staff positions where needed. [https://www.omao.noaa.gov/learn/noaa-corps/about].

I could write a short novel on my brief time with the NOAA Corps, but for this discussion I will leave it as just my pathway to NOAA's Office of Law Enforcement. I will only say that the old adage of "Be careful what you ask for" certainly applied.

It was near the completion of my first sea assignment when I found out that NOAA OLE existed. I heard there was an opportunity to work with the enforcement section of NOAA as a land assignment. I eagerly volunteered and was sent to the same training as the civilian enforcement personnel at FLETC and quickly exported to the field so they could get the maximum use of my two year rotation.

I was lucky to have been sent to the Southeast Division where they put me to work. The experience allowed me to transfer to civilian status at the end of my obligation to the NOAA Corps. The rest, as they say, is history. However, that brings me back to the original question of what does NOAA enforcement actually do?



Although NOAA OLE is housed in the Marine Fisheries Service it is the enforcement arm of all of NOAA through line authority. This gives OLE jurisdiction to enforce all laws administered by NOAA as well as all statutes related to its mission which involves over 100 legislative acts under 32 statues pertaining to the conservation and protection of marine resources.

The NOAA OLE website [https://www.fisheries.noaa.gov/ about/office-lawenforcement provides the following.

"OLE is dedicated to enforcing laws that conserve and protect our nation's marine resources and their natural habitat with the goal to ensure a level playing field for honest fishermen, defend U.S. economic and public health interest from illegal international and domestic fishing activities, and protect vulnerable marine species in order to ensure these global resources do not disappear."



The description is a bit generic. In layman's terms, NOAA OLE investigates violations of federal living marine resource and habitat protection laws and regulations from minor infractions to complex criminal cases. The five main acts enforced are,

Magnuson-Stevens Fishery Conservation and Management Act **Marine Mammal Protection Act Endangered Species Act National Marine Sanctuaries Act** Lacey Act (International and Interstate smuggling of fish and wildlife).

There were very few enforcement personnel to cover NOAA's area of responsibility. When I was in the Florida Keys I covered the entire length of the Keys from south of Miami out to the Dry Tortugas. When I transferred to South Carolina I was the sole agent for the state. Another agent was north in Morehead City, NC, and one to the south in Brunswick, GA. I covered between Wilmington, NC, to Savannah, GA, and worked a couple of larger cases out of Miami, FL.

A NOAA agent may be working with the USCG or a state agency on a violation committed by a local commercial vessel or business one day, and then the next be dealing with the US Attorneys Office on a multi-year, international poaching investigation involving several jurisdictions and companies. As such, NOAA enforcement personnel have to be well versed in both civil laws and legal authorities as well as criminal laws and authorities. And, more importantly, when a case transitions from civil to criminal triggering a change in legal limits.

NOAA agents utilize all of the techniques and resources traditional law enforcement uses in their investigations, such as confidential informants, undercover operations, surveillance technologies, and forensics. But, unfortunately, most NOAA cases are not hot news items nor does the Agency really try to seek widespread reporting of enforcement cases. So, few know of the great work by the enforcement personnel in NOAA or their contributions to other federal enforcement efforts.

In addition to the Agency's mission, NOAA enforcement personnel are assigned to other agencies in times of national disasters. The Agency routinely assigns personnel to work with FEMA teams in areas affected by hurricanes to keep the team's personnel and equipment safe.

In the past it has provided investigators to narcotics task forces when fishing vessels or businesses are involved, and also to national enforcement efforts such as the FBI's World Trade Center investigation and Federal Air Marshal

At one point in my career I seriously considered transferring to another agency for various reasons. In reviewing the options and talking to other agents I came to the conclusion that, at least for me, I was in the best agency and role possible. I never regretted that decision in all of the years I remained with NOAA (Well, maybe a couple of times).
